We understand the pressures that businesses face in the current operating climate, both in terms of the time commitments involved in undertaking training, and costs.

It is our belief that safety training should be both accessible, and affordable. Our training offer is designed with flexibility in mind, to suit your individual business needs.

We offer a range of one, two, and three-day training courses. All courses can be taken face to face, in a classroom setting. We provide the venue for public courses, or for large enough private groups, we can also come to your site.

For IOSH courses, in addition to the traditional classroom option, we offer online delivery via a 'Virtual Classroom' setting, delivered over Teams, or Zoom. For most First Aid courses (except for the Emergency Paediatric First Aid course, which must be delivered solely in-person to meet EYFS requirements), learners can choose between the full classroom setting or undertaking training via blended learning. This offers combined e-learning via the RLSS UK platform, prior to classroom-based practical assessments. It is designed to enable learners to undertake the e-learning in their own time, reducing the hours required to attend in person for the practical elements.

EMERGENCY FIRST AID AT WORK

AUDIENCE: STAFF

DURATION: ONE DAY

Individuals and organisations are advised to take an Emergency First Aid at Work (EFAW) course to provide and deliver first aid skills within their workplaces. It covers a range of CPR and emergency first aid skills. Candidates must be a minimum of 16-years-old at the time of taking the EFAW assessment, and no prior first aid knowledge is required. It would suit all staff working in a lower risk environment or who are not the designated first aid lead.

EFAW is a 6-hour course that is trainer assessed and can be delivered in-person, or via blended learning, for greater flexibility. It comprises of practical and theoretical work. There is a practical assessment on CPR and first aid, and all assessment criteria must be achieved to pass the course. Upon qualifying, the EFAW certificate is valid for 3

EMERGENCY PAEDIATRIC FIRST AID

DURATION: ONE DAY

Individuals and organisations are advised to take an Emergency Paediatrics First Aid (EPFA) course to provide and deliver emergency first aid skills to children and infants (babies) within their homes or workplaces. It covers a range of CPR and emergency first aid skills specifically for children and infants (babies) – because their first aid needs differ from those of adults. Candidates must be a minimum of 16-years-old at the time of taking the Emergency Paediatric First Aid assessment, and no prior first aid knowledge is required.

This course would suit those working in childcare settings who wish to provide paediatric first aid support, but are not the designated paediatric first aid lead, as well as parents and guardians. It is a one day (6 hour) first aid qualification that is delivered in person to comply with the Early Years Framework (EYFS). It is trainer assessed and comprises of practical work and theoretical classroom work. There is a practical assessment on CPR and first aid, and all assessment criteria must be achieved to pass the course. Upon qualifying, the

PAEDIATRIC FIRST AID

DURATION: TWO DAYS

The RLSS UK Qualifications Level 3 Paediatric First Aid (PFA) qualification covers a wide range of CPR and first aid skills, equipping the first aider to administer first aid to children and infants (babies).

The two-day Paediatric First Aid qualification is [Ofqual](#), [CCEA](#) and [Qualification](#)

[Wales](#) accredited and valid for three years after the date of assessment. It is suitable for anyone who has contact or works with children and infants (babies).

The Paediatric First Aid course content can be covered within 12 hours over two days or a blended learning version of the course is also available. The course comprises practical work and theoretical classroom work, as well as a practical and multiple-choice theory assessment of CPR and first aid.

Upon qualifying, the PFA certificate is valid for 3 years. To renew a Paediatric First

Aid certificate, candidates must re-qualify by being assessed against all learning outcomes and assessment criteria for the qualification. A renewal is achieved by redoing the initial 12 hours of course content.

The next step is to complete other first aid courses including, Emergency First Aid at Work (EFAW), First Aid at Work (FAW), Automated External Defibrillator (AED) Programme or, become First Aid Trainer.

DURATION: THREE DAYS

Individuals and organisations are advised to take a First Aid at Work course to provide and deliver first aid skills within their workplaces. The First Aid at Work (FAW) course is the most comprehensive first aid training for the workplace. It covers various CPR and first aid skills and equips first aiders with the knowledge to apply first aid to specific injuries and illnesses. It is suitable for all industries and enables employers to meet HSE and HSENI requirements. Candidates must be a minimum of 16-years-old at the time of taking the First Aid at Work assessment, and no prior first aid knowledge is required. This course would suit those working in higher risk workplace environments and those who have responsibility as a designated first aid lead.

The First Aid at Work (FAW) course is 18 hours in length and can be delivered over three consecutive days either in-person or via blended learning. The FAW course comprises practical classroom work and theoretical work, as well as a practical and multiple-choice theory assessment of CPR and first aid. Upon qualifying, the FAW certificate is valid for 3 years.

The First Aid at Work (FAW) qualification expires three years after the date on the certificate. Candidates must re-qualify before the expiry date of their existing qualification. *If you fail to requalify prior to the expiry date of your existing certificate, you may still be able to requalify by successfully completing a two-day First Aid at Work requalification course within 28 days (following your qualification expiry date).* *NB: you are not permitted to act as a first aider until you have requalified.* To re-

FREQUENTLY ASKED QUESTIONS

If you are considering booking a course, here is some general information that applies to most of our training. If you have any further questions, then give us a call.

How do I book onto a course?

You can find out about available course dates and book onto one of our courses by email (bookingenquiries@finnsafetytraining.co.uk) or by giving us a call on 07930 366 435.

What should I bring to my virtual / in-person training?

Just yourself, some ID for course registration, a pen, and (for virtual courses only) a laptop with good internet access. We provide all course-related materials linked to your training.

What should I wear for first aid training?

It is advised you wear something comfortable, such as trousers, and t-shirt, or jumper. Practical tasks require you simulate and treat injuries or medical incidents, so may require you to kneel or lie down. Bringing a knee rest could be more comfortable for floor work.

Do I need specialist software to access e-learning for a blended first aid course?

No, you don't. Upon enrolment, you will receive an email that includes signup information for the RLSS UK e-learning platform. You will then be able to work through the required e-learning modules at your own pace, ahead of the in-person practical learning associated with your course. Please note that the e-learning must be completed before you attend the face to face training.

What is the split between online and in-person training on a blended first aid course?

This depends on the course chosen. It is designed to make the training experience more flexible, with less time out of the office required for practical training and assessment, and the option to work through the e-learning at your own pace. The split between online and face to face training on a blended first aid course is roughly as follows:

- Emergency First Aid at Work EFAW – 1 Day (6 hrs): 3 hrs e-learning & 3 hrs in-person*
- Paediatric First Aid (PFA) – 2 Days (12 hrs): 6 hrs e-learning & 6 hrs in-person*
- First Aid at Work (FAW) – 3 Days (18 hours): 6 hrs e-learning & 12 hrs in-person*

Please note that the Emergency Paediatric First Aid (EPFA) cannot be taken via blended learning as EYFS requirements state that it must be completed in-person only.

How large are the class sizes?

Most classes for first aid training are between 6-8 people, although we can accommodate up to 12 individuals in one cohort. For IOSH training, typical class sizes are again around 8 people, although we can accommodate up to 20 individuals maximum in one cohort.

What happens if a course is cancelled?

We do not cancel courses lightly. If a course has to be cancelled, we will call all participants as soon as we can to rearrange the training.

What happens if I am unable to make it on the days I am meant to attend?

Please let us know as soon as possible if you will be late, or unable to attend. A few minutes late may be ok, but due to the modules that must be undertaken to take the assessments, your training may need to be rebooked. If it can be avoided, it is best not to miss any of the training.
